- The TUI STARS commission also applies to all Gebeco small group revenues including cycling & hiking tours. These are marked in the booking system at Gebeco Reisen, die begeistern with the abbreviation „Small“ for small groups and „Active“ for hiking & cycling tours.
- TUI STARS packages vary, depending on the date of arrival, airport of departure, hotel, length of stay and carrier per route.

■ Increased basic commission (immediate deduction)

When a minimum turnover of 70,000 Euro has been reached, the basic commission is **10 %**. For agencies achieving min. 250,000 Euro turnover in F/Y 2022/2023, the basic commission is **11 %** (or **10.5 %** at a turnover of min. 150,000 Euro). Agencies achieving less than 70,000 Euro receive **7 %** basic commission.

■ Scaled commission

Your total TUI turnover in F/Y 2023/2024 will determine your commission rate. You can reach up to **1.2 %** scaled commission. At the end of each financial year, your scaled commission will be calculated on the base of the category achieved and credited to your commission-relevant turnover.

■ New agencies

are classified with **8 %** basic commission. Upon achieving the minimum turnover you will receive the difference on your final settlement.

■ Minimum turnover remains 70,000 Euro

If the TUI total turnover for the F/Y 2022/2023 is less than 70,000 Euro, the basic commission for the F/Y 2023/2024 will be **7 %**. If the minimum turnover of 70,000 Euro is achieved by the end of the F/Y 2023/2024, the difference between basic commission and the achieved total commission will be credited and the basic commission for the next financial year will increase to **10 %**, **10.5 %** or **11 %**.

■ No penalty

Failure to comply generating minimum sales, paid commissions are not charged back.

Your gross sales of group bookings are relevant for the calculation of the index of your scaled commission, but not for the commission itself. Therefore you can rise to a superior sales class even faster and consequently earn a higher commission.

TUI CARS

TUI CARS sales less local taxes (incl. motorcycles) are included in the TUI total turnover.

■ Short- and mid-haul destinations

For your TUI CARS sales (less local taxes) in Europe, North Africa and Western Asia* you receive a **15 %** flat rate commission.

■ Long-haul destinations

For all TUI CARS sales (less local taxes) at long-haul destinations you receive your individual basic- and scaled commission.

TUI CAMPER

All TUI CAMPER sales are included in the TUI total turnover and you receive your individual basic- and scaled commission. This also includes all prepaid extras such as miles packages.

* TUI CARS mid-haul destinations: Europe (incl. Azores, Canary Islands, Madeira); North Africa (Egypt, Morocco, Tunisia, Cape Verde); Western Asia (Israel, Turkey)

TRAVEL INSURANCE

Selling customised travel insurances provide you with an attractive commission. All travel insurance bookings from these programmes increase your TUI total turnover.

Special Regulations

Cancellation fees

- Turnover from cancellation fees is not included in the TUI total turnover, but will be fully remunerated (**5 %** immediately and the difference to the total commission at the end of the year).

Rebooking fees

- You will receive **5 %** commission on rebooking fees. These do not count to the TUI total turnover.

Other fees/charges

- No commission will be paid for fees such as taxes and charges of all kinds.

Flex tariff upgrade

- The flex tariff upgrade will be fully remunerated with your individual scaled commission. In the event of cancellation, a 50 % share of the fee will be credited on your next agency settlement.

Private travel agent bookings

- No commission is paid on private travels of employees. These sales are not included in the TUI total turnover.

Other hotel rates

- Turnover of „other hotel rates“ with special cancellation conditions (e.g. „no cancellation free of charge! **80 %** cancellation fee upon booking“ or „free cancellation until 6 p.m. at the day of departure“) counts towards your TUI total turnover. For these sales you will receive **8 %** basic commission and **2 %** fixed commission paid with your final settlement. A deposit of 20 % will be due immediately after booking and debited from your agency account.
- The „Zusatzangebot“ hotel rate, which is visibly identified with that label. You can find detailed information on TUI NEWSNET. These sales also count towards TUI's total turnover and are remunerated at **8 %**.

Event tickets

- Ticket Only: Sales of event tickets as single service (entrance fees without advance booking- and system fee) are included in the TUI total turnover and attract **10 %** commission (**7 %** for agencies below minimum sales, **8 %** for new agencies). Valid for sales from 01.11.2023 to 31.10.2024. The event tickets on offer are brokered by TUI Deutschland GmbH in the name and for account of the specific event organiser.

- Combined ticket: This may be used together with a TUI hotel as a TUI package only. Purchases using this ticket (admission charges, not including advance booking- and system fees) with a travel date between 01.11.2023 - 31.10.2024 are compensated with your individual basic commission of at most **10 %** and count towards your TUI total turnover.

Individual Coupon-Code (Web-Coupon)

- Turnover generated by bookings involving the redemption of individual Coupon-Codes (Web-Coupons) that are offered to selected website visitors and that can be used to cover part of the cost of a firm booking will as a rule attract basic commission of a maximum of **10 %**. This also applies to product packages marked as TUI STARS.

Additional products („Additional Services“)

- Additional products are in particular all products in addition to accommodation- or flight services, which are offered via IRIS.plus „Extras“ note window „Zusatzleistungen“/„additional services“, „Further“ (i.e. food & drink packages, transfers, tourist visas, sport packages, excursions, catering on board and Tourist train tickets incl. -upgrades if not booked free of charge). These additional products, independent of the destination and product line, count to the TUI total turnover and are commissioned with **5 %**. Ancilleries e.g. seat reservation will count to the total sales and will be also commissioned with **5 %**.

TUI experiences

- TUI experiences sales count towards the TUI total turnover. You receive a fixed commission of **15 %** on your TUI experiences sales which will **soon be bookable via IRIS.plus**.
- TUI experiences (via TUI MUSEMENT S.p.A.) bookable via a personalised affiliate link: The experiences are offered by TUI MUSEMENT S.p.A. These sales of TUI experiences bookings as individual services are remunerated directly by TUI MUSEMENT S.p.A. with the respective commission. Sales of private transfers offered by Mozio will not be included in the TUI total turnover.



TUI special offers

From the product portfolio of the brands TUI and airtours, we are providing special offers for specific destinations, hotels or individual product services in a specific promotional period. These offers are marked separately in IRIS.plus.

TUI BASIC special offers

- Bookings of TUI "Basic" special offers are commissioned with a maximum of 10 %.

TUI CHANCE special offers

- Bookings of TUI "Chance" special offers are additionally remunerated as an incentive with at least 2 % and more on top of the applicable commission. You can find the amount of the currently applicable incentive from the product identification in IRIS.plus.

airtours

- Bookings of the product Cruise attract a fixed commission rate of **12 %**. This turnover counts towards your total TUI turnover.
- For bookings of the following, you will receive a fixed commission rate of **5 %** and the turnover counts towards your total TUI turnover:
 - Event tickets, bookable transfers and trips without accommodation, excursions and golf packages.
- Add-ons to cruise bookings (such as flights, shipping company flight packages, transfers and other travel packages, event tickets and tour packages) do not count as part of your TUI total turnover.

Internet

- Please note that these conditions do not apply to online sales. A separate agreement is required in this case.
- The relevant content (booking information, image and text material) is made available by TUI through various booking tools and databases (currently Traveltainment, Peakwork, partly Traffics, Giata, TravelCMS). Please contact your selected service operator for information on integration of this content on your website.

Itur

- Itur sales are part of your TUI total turnover. You will receive a commission to a maximum of 10 %.

Gebeco Reisen, die begeistern (incl. Gebeco Studienreisen and Adventure Trips by Gebeco)

- For Sales of Gebeco group tours you will receive an on-top commission of 0.1 % at the end of the year.
- **NEW:** In addition, you will receive 0.5 % on top for all sales of Gebeco small groups and Gebeco hiking & cycling tours.
- All flights from Gebeco are included in your TUI total turnover.
- For all flights in economy class, published in the catalogue, you will receive full basic/scaled commission.

- Fixed compensation of 25 Euros per person is granted for First-, Business Class and „Premium Economy“ class surcharges published and for flights not published in the catalogue. You are also able to add an optional service charge (OSC).

Flight Net sales

- Flight only products are available in IRIS.plus on up-to-date rates and count to your TUI total turnover.

TUI Ticket Shop (TTS) – your specialist for flights

- Also part of the TUI total turnover are the corresponding flight charges; this excludes taxes, other payments and surcharges imposed by the airline. The TUI Ticket Shop rates are net fares. Note: The departure date shown on a ticket booked through TUI Ticket Shop will determine to which financial year the turnover will be credited. For more details on TUI Ticket Shop, its credit card payment conditions, taxes and other payment options, please see the booking instructions and the corresponding lists. Fly & Mix/Fly & Mix Flex - flight module only in combination with a TUI land arrangement

- No commission is generated by the flight module of a 'Fly & Mix and Fly & Mix Flex' booking. However, you may add an optional service charge (OSC) at your own discretion. This will apply per person, children and adults alike. You can select an OSC within a fixed range of € 1 to € 10. Different rates can be combined with each other. The OSC is included in the end price and is not visible to the customer. It will be deducted from overall settlements to the travel agency and is not added to your TUI turnover. Turnover generated by the flight incl. taxes and fees as well as the TUI land arrangement will be credited to your total TUI turnover. The additional service "Upgrade to Fly & Mix Flex" counts towards the TUI total turnover but is not taken into account for the commission. In the event of cancellation, a 50 % share of the fee for the Flex tariff upgrade will be credited on your next agency settlement. You will find further information on TUI NEWSNET.

TUI flight-only departing Austria (operator TUI Deutschland GmbH)

- TUI charter flights departing from Austria can be booked as stand-alone services but do not attract commission. You also have the option of adding an OSC. The net turnover forms part of your total TUI turnover.

TUI fly flight portal

- Certain flight turnovers booked through the TUI fly flight portal count as part of your total TUI turnover.



General Terms and Conditions 2023/2024

Agency number

Please note that your own agency number is a prerequisite for this cooperation. Separate agreements are required for Gebeco Reisen, die begeistern, TUI experiences, TUI fly Vermarktungs GmbH and TUI Ticket Shop. No reservation/booking can be accepted without an agency number.

Payment of deposits

On conclusion of a contract, the deposit specified in the terms and conditions of travel is to be collected by you; you are also obliged to collect the balance when the travel plan or travel documents are released to the customer. Please ensure that one of the methods of payment specified in the travel confirmation is used. You are not authorised to collect deposits at an earlier point of time nor are you authorised to collect deposits/balances exceeding those specified. If you fail to collect the sums in question, you will be held liable for the full costs of travel and for any costs arising in connection with collection of the outstanding amounts. If the customer cancels, you will be liable for the cancellation charge and any costs arising in connection with reimbursement and other costs. You undertake to appropriately retain and safeguard the payments collected from a customer. You are aware that you may be prosecuted for failure to retain and safeguard such payments.

Bank guarantee

A valid bank guarantee in the amount of 20,000 Euro per agency in favour of TUI Österreich GmbH is a prerequisite for this cooperation. We specifically reserve the right to call up a bank guarantee of up to 50 % of the sales at any time and without giving reasons. The bank guarantee may be called up for all justified claims of all group companies.

Booking and distribution of documents

Booking of a holiday is carried out in accordance with the booking instructions. This also includes the collection of all customer data including address, E-Mail address, telephone number and mobile phone number for the SMS Assistant, as well as the selection of the payment method in IRIS.plus. The requirement of data correctness applies. The indication of travel agency data in the customer data fields in IRIS.plus is not allowed. You do not have the right to make statements and/or promises over and above those of the services offered by TUI. In accordance with the stipulations of the new travel package directive (Pauschalreisegesetz), you will provide the customer with the precontractual information provided on IRIS.plus and the package travel form required prior to option/booking of a travel package. You will also inform the customer of the applicable General Terms and Conditions, particularly the travel conditions and the form in

which payment is to be made before their travel booking can be confirmed, and ensure that the customer agrees with these. It is mandatory that our common customer signs the original travel schedule/travel documents published in IRIS.plus and therefore accepts the booking conditions from TUI.

Prices

You shall book the tours exclusively in accordance with the prices given in the catalogue or up-to-the-minute offers and shall desist from any actions unfairly impairing other agencies in their sales activities for TUI products. You may not independently grant price rebates on TUI sales prices. The fixed TUI travel price must always be given on public advertising and on invoices and other travel documents. You are always liable towards the specific TUI company, pursuant to the Terms and Conditions, for the full amount due to TUI after deduction of commissions for the booked travel services. Any violation of these instructions constitutes a reason to terminate the cooperation according to the Commercial Agents Act. In any case the basic commission shall be reduced to 10 % or lower, if the existing scale is lower already.

Invoices, agency settlement

are made available exclusively in the TUI web archiving system.

Information, IRIS.plus queue

We communicate relevant information for a certain booking process using the usual electronic communication media, but also through the IRIS.plus queue. The usage or observation of the IRIS.plus queue is therefore mandatory. We cannot be held liable for information that is not observed or not forwarded to the end customer, or forwarded too late.

Validity

Terms and sales conditions are valid exclusively for the financial year 2023/2024 for our contract partners with head offices in Albania, Bosnia-Herzegovina, Bulgaria, Croatia, Czech Republic, Estonia, Georgia, Hungary, Israel, Kosovo, Latvia, Lithuania, North Macedonia, Moldavia, Montenegro, Romania, Serbia, Slovakia and Slovenia, for all bookings with departure dates between 01.11.2023 and 31.10.2024 and for all TUI tour operator brands and product lines. They are valid exclusively for stationary travel agency sales. Individual arrangements are required for non-stationary sales routes such as network marketing, the internet, call centres or similar. The transfer of rights/obligations under this contract to other branches, agencies or third parties is subject to our prior written consent. You will be informed of the terms applicable to 2024/2025 at the beginning of the financial year.

Security certificate for package tours (Sicherungsschein)

A security certificate for package tours as per the PRG (Pauschalreisegesetz) is printed on the back of the travel confirmation/invoice from TUI Deutschland GmbH, if the booked product is a package tour.

Tour operator's margin tax

In the case of TUI, Gebeco Reisen, die begeistern (incl. Gebeco Studienreisen & Adventure Trips by Gebeco), airtours, XTUI as well as ltur bookings, you are considered to be the agent only and the tour operator is thus liable to pay the margin tax.

Deductions from account

When invoicing, 11 % basic commission will be deducted for agencies with a total turnover greater than 250,000 Euro in 2022/2023. The corresponding deductions will be 10.5 % for agencies with a turnover greater than 150,000 Euro, 10 % for agencies with a turnover greater than 70,000 Euro, 8 % for new agencies and 7 % for agencies that do not achieve the minimum sales.

Minimum turnover

Minimum turnover per sales agency is 70,000 Euro. Should you fail to achieve the requisite TUI minimum sales in the financial year 2023/2024 (01.11.2023 to 31.10.2024), we reserve the right to close the agency number. In any case the basic commission for the following financial year (2024/2025) will be reduced to 7 %. The turnover of newly opened agencies will attract a basic commission of 8 %.

Settlement of final commission (Overriding)

Your individual commission shall be calculated at the end of the financial year 2023/2024 (01.11.2023 to 31.10.2024). You will receive the statement for the scaled and additional commissions for all the sales attracting commissions (see page 4) in December 2024. Scaled and additional commissions will be paid by a credit note to your agency account.

Advertising

For the duration of the contractual relationship, you undertake to make customers aware of all brands and to promote these in accordance with their market relevance. This applies to shop window displays, presentations within and outside your premises and the home page of your website. Agencies may only use TUI brands, names and logos to promote TUI products online in accordance with the conditions of each valid trade mark directive. The use of TUI brands as keywords for search machine marketing is explicitly prohibited.

If an agency employs TUI brands for the promotion of TUI products in electronic price comparison, sales management and/or booking systems (such as online booking engines), the agency must ensure that TUI products and brands are presented in a manner identical to that of other promoted tourism services of other operators, and are neither sidelined nor concealed. In case an agency demonstrably violates the obligations above, TUI reserves the right to retroactively reduce its commission to 7 % on all turnover achieved in the financial year in question. TUI also reserves the right to impose additional penalties.

Terms of payment

B2B SEPA Mandates are obligatory for agencies in the Euro Monetary Union. The account will be debited approx. 4 weeks prior to departure (except TUI Ticket Shop, TUI CARS and deposits for "Other hotel rates").

In the event of even a single unjustified refusal of our debit order, we reserve the right to bar the agency from new bookings and/or cancel this agency contract with immediate effect. Agencies in source markets with another currency than Euro shall make a transfer immediately after the receipt of the agency account. If no transfer is made before the date of departure, we reserve the right to bar the agency from new bookings and/or to cancel the agency contract with immediate effect. The claim to the scaled commission over and above the basic commission is forfeited with immediate effect when the agency is barred and/or cancelled, without prejudice to the assertion of claims for additional damages. You agree in giving us your consent for electronic processing of all arising data from this agreement. We reserve the right to access your current business records in the event of conspicuous or repeated payment irregularities.

Direct collection in Euro-zone countries

We reserve the right to switch the agency to direct collection in the case that the above-stated payment conditions are not observed. In addition, we can switch your agency to direct collection, with or without agency collection, if desired. Direct collection/agency collection is only possible for agencies in Euro-zone countries. This requires the signing of Annexe I. Settlement regulation for direct collection.

Payment by customers credit card

TUI Deutschland bookings (TUI, airtours, l'tur and XTUI) can be settled by customer's credit card Visa, MasterCard, Diners Club and American Express.

Data protection

- Information pursuant to Art. 13 GDPR: The data controller is TUI Österreich GmbH, Heiligenstädter Straße 31, 1190 Vienna, Austria. Our data protection officer can be contacted at datenschutz@tui.at. Within the scope of our contractual cooperation (agency contract), we process personal data of you and your employees. We use the personal data collected exclusively for the purposes of our contractual relationship, as well as for correspondence and contacting you. For this purpose, we may have to share the personal data with other companies of the TUI Group. The data will only be stored for as long as is necessary for the purposes outlined and/or to comply with statutory retention periods. You have the right of access to the relevant personal data, as well as the right to rectification, erasure, restriction of processing, objection and data portability. Furthermore, you have the right to lodge a complaint with the data protection authority at www.dsb.gv.at.
- Further information on the subject of data protection: Please take into account that you (your agency) are the data controller vis-à-vis end customers in accordance with the GDPR. You process (collect, retain, transmit, etc.) their personal data and are subject to your own duty to inform them pursuant to Article 13 of the GDPR with respect to how you process their personal data. It must be specified, among other things, to which recipients or categories of recipients data is transferred. These include, inter alia, tourism service providers such as tour operators. TUI Deutschland GmbH, as whose general sales agent we act, operates - as do any other service providers from the TUI Group - as an independent data controller. The data you provide shall only be processed for a specific purpose and on the basis of an appropriate legal basis. TUI Deutschland GmbH makes every effort to ensure the greatest transparency by means of its own data protection notice, available at www.tui.com/datenschutz. For this reason, it is recommended to make this information available to your customers. The processing of data for marketing purposes is carried out in the legitimate interest, appropriately and exclusively within the permitted scope. TUI Group companies apply extensive and cost-intensive marketing measures to actively enlarge your customer base, whereby the customer data that becomes known through the booking process is not used to initiate new mediation activities.
- The principle of data accuracy requires that you enter correct customer data into TUI systems (e.g. IRIS.plus) without exception. It is not permitted to enter agency data instead of customer data. The use of the SMS Assistant is obligatory and also requires the entry of complete customer data in IRIS.plus. This data is transmitted to the relevant TUI company for the purpose of providing the services of the SMS Assistant. This concerns information about unforeseen events in connection with the booked travel or general information about transfers and other booking-related services.

Miscellaneous

It is agreed that the exclusive place of jurisdiction for all disputes arising under this contract shall be the court in Vienna with relevant jurisdiction. Austrian law is exclusively applicable. Amendments and side agreements to this contract shall be in writing, which shall also be applicable to a waiver of the written form requirement itself.
